








Regional Metropolitan Phoenix Fire Service Automatic Aid System. Units in green when available.



DMFD Letter to Carrie Dyrek, Cave Creek Town Manager

We share borders, great citizens, and the beautiful Sonoran Desert. We are available to help you. We've reviewed the PSRM report which identified a few outcomes that we believe would be in the best interest of your citizens and Town. In order to continue to receive the support and resources of Daisy Mountain Fire District and the Regional Metropolitan Phoenix Fire Service Automatic Aid System we need one of the following options to occur. We readily welcome any feedback and look forward to your response.

- *The DMFD requests a **commitment by the Town** to organize and structure a Fire Department that meets the standards and requirements of "**Article 2-AUTOMATIC AID ELIGIBILITY STANDARDS AND REQUIREMENTS**" of the IGA for the Regional Metropolitan Phoenix Fire Service Automatic Aid System in order for the DMFD to continue to respond to the Town in an **effective, coordinated, safe and efficient manner**;*

During May of 2020, multiple wildland fires occurred within the Town of Cave Creek. Because Cave Creek does not have a town-funded or contracted fire department, these fires resulted in a significant Phoenix and Regional Fire Service response that included over 184 different fire department resources. The level of support provided had the practical equivalent of fielding not only a mutual aid type response, but a de facto Cave Creek Town Fire Department. Additionally, absent a formal Town of Cave Creek Fire Service, any assistance provided by the City of Phoenix or another jurisdiction does not constitute mutual aid. This is an unsustainable and inequitable approach going forward.

When such a large-scale deployment of Phoenix and regional resources outside of the Automatic Aid Consortium system occurs, the system's overall service delivery capacity is negatively impacted. This impact results in the need for further movement of resources to maintain service levels for the region. The Regional Automatic Aid System is the result of an agreement among 22 separate Fire Departments to allow for the automatic dispatch and response of emergency resources within the participating jurisdictions, regardless of geographical boundaries. While the system provides a greater level of effectiveness and efficiency for each member than could be achieved individually, it is **not intended to replace the responsibility each jurisdiction has to provide Fire Service to their community**. When an imbalance occurs, participants in the agreement are required to provide the necessary resources to return the balance.










